# 1) Diversion Update

- Data below shows tonne of tires supplied, collected and delivered.

## 2) Tire Collection Update

### **Collector Filing**

- Collectors are to file as per the norm.
- Please review all transactions with haulers as there have been complaints of some tire counts being increased on claims.
- Mobile transactions <u>do not</u> automatically submit the collector's claim
- Tire Origin Logs are to be completed when submitting the claim
- OTS has updated the QR codes that were rendering a string of registration numbers from being acknowledged.



# 3) Tire Transportation and Delivery Update

- Mobile Device Users (Haulers & Processor) if there is any mobile transaction that was sync'd after you submitted your claim, the mobile transaction will go into the correct claim month as long as the claim is not approved by OTS yet. If the claim is approved, the mobile transaction that was sync late, may be made invalid.
  - Syncing daily would help the above from not occurring
- Yard Counts Reminder to be very accurate on your yards errors are still being reported
- For any loads not in usual trends (high variance, high load counts), OTS is again reminding haulers to take a picture of the load as this will provide support to that transaction (ex. Any loads greater than 1100 tires)
- Reminder Please submit monthly claims.
- Haulers cannot submit a claim if there are incomplete, pending or pending added transactions. Please make sure all are completed prior to submitting
- Please verify that all tire count numbers are accurate. Collectors have been contacting OTS that some numbers are incorrect when filing their claims.

# 3) Tire Transportation and Delivery Update

- Please make sure you are scanning the <u>correct badge</u> for those hauling themselves and another hauler.
- OTS will no longer correct these errors.
- Any transactions that are requested to be voided, it is known that a pickup/dropoff did occur and thus OTS will request a form that will replace the voided request.

# 4) Tire Processing & Manufacturing Update

#### **Processors**

- Scale tickets are always required for transactions
- Processor Bonds Reminder that all updated bonds have been sent out based on the 2016 deliveries to all processors.
- Due date for updated payment is February 28<sup>th</sup>, 2017.
- Mandatory Yard Counts for Processors due Feb 28<sup>th</sup>, 2017.
- Trailer storage for shred ends on Feb 28, 2017.

### **Manufacturing**

• Scale tickets are always required for transactions



## 5) TI Adjustment Review

- Primary purpose of the review was to guide the adjustment of the non-fuel cost components included in the model
- TI uses a combination of cost estimates and other cost assumption using reliable independent sources such as the Consumer Price Index and the Labour Mark Index
- An open invite was sent to all haulers in the program to do a review of their cost
- 14 haulers accepted the invitation to present issues and cost information relating to the hauling of scrap tires.

## con't... - Identified Cost Elements

- The following points were identified as areas to which an adjustment would be required for the Transportation Incentive.
- Cost of Living Transportation
  - The cost of operating a truck was originally derived from Transport Canada studies and the non-fuel components of the costs are adjusted based on changes to the CPI index for transportation in Ontario, except for Insurance which is detailed below.
- Truck and Facility Insurance
  - Insurance rates are higher for haulers who reclassify themselves as a tire hauler than for general haulage
- GTA Travel Times
  - The steady deterioration of the travel times in the GTA zones were an issue, therefore an increase in collection times was added to the model.
- Overall impact of the review is a 5.7% increase in TI rates. Fuel Adjustment is approximately 1.3% of the 5.7%




