1) Diversion Update

- Data below shows tonne of tires supplied, collected and delivered.
- Jan 2012 Nov 2012
- Supply weight is based on old tire weight
- Collected weight is based on estimated weight
- Deliveries is based on actual weight

2) Tire Collection Update

- Tires being collected from locations by Haulers as applicable
- Hauler should cross reference the OTS website daily against the "Find a Participant" link to ensure the Collector is active in the program at the time of collection.
- OTS is now sending weekly notifications to all Haulers regarding Collector inactivation's.
- See Section 2.5 of the Collector Guidebook regarding making changes to a registrant information (i.e Change in Postal Codes, Change in Legal Business Names, Businesses that have been purchased or taken over).

3) Tire Transportation & Delivery

Ad Hocs & Redirects: No requests for On the Road Tires. Low volume requests for OTRs redirects/Ad hocs, on OTR Tires.

b) STC Review/Updates:

Number of STCs approved in October: 7

4) Tire Processing & Manufacturing Update

- Capacity for all tires types increased over last year on average
- Manufacturers: actively participating in promotional activities with OTS
- **New Requirements:** Mandatory yard counts twice a year for all registered OTS Processors. Processor yard counts will include unprocessed tires and unsold material. OTS will notify Processors on when to send in their yard counts. Downward adjustments will be made using the yard counts (if applicable) to correct closing inventory balances.
- OTS Processor Guidebook will be updated to reflect this bi-annual request.



5) Claims Update

Collector Claims:

- Collector claims filing in accordance with typical trends
- OTS has increased the number of inquiries to Collectors requesting tire count support to justify their Collector Claims.
- Collectors are responsible and obligated to ensure that the information filed on their behalf by a third party must be true and accurate. (i.e. Tire counts claimed, Dates of collections, Collection tire logs etc.)

Hauler Claims:

- Yard Count required for all haulers with their November 2012 submission.
- Haulers filing in accordance with typical trends
- Next mandatory Hauler yard count expected for possibly June 2012.
 OTS will notify Haulers in advance regarding the mandatory yard count.


5) Claims Update

Processor Claims:

Processors claims continue to be filed as normal

RPM Claims:

Continue to file as usual



6) Stockpile Update

- RFP awarded for an Environmental consultant to review stockpile sites outlined by MOE.
- Once review is completed, same process before where RFP will be sent out to Processors (Contract awards will consider end use of material (i.e. TDP type and supply to an RPM) as well as cost
- Looking at combining sites for efficiency in certain areas
- RFP for a site to be released for a site in the North finalizing with the land owner


7) Program Communications

- Still at the very early startup stage eg. how it will used, how many are needed per registrant, interactions with collectors and processors, online claims etc.
